**MEMORANDUM OF ASSOCIATION**

- I. 1. Name : The Name of the Society shall be  
 "The Corporate Educational Agency of  
 the Catholic Diocese of Tiruvalla"
2. Registered Office : The Registered Office of the Society shall be at Catholic  
 Bishop's House, Marygiri, P.B. No.4, Tiruvalla, Kerala,  
 India - 689 101.
3. Address : Catholic Bishop's House, Marygiri, P.B. No.4,  
 Tiruvalla, Kerala, India - 689 101.
4. Area of Operation : The area of operation shall be the whole of India.

II. **AIMS AND OBJECTIVES:** The society is established for the promotion of Education,  
 Literature and Science, the diffusion of useful knowledge, and charitable purposes.

The means employed for the attainment of these objects are:-

(a) The provision and maintenance of Colleges, High Schools, Secondary Schools,  
 Primary Schools, Nursery Schools, Day-Care Centres, Industrial Schools, Agricultural  
 Farms, Orphanages, Dispensaries, Places of Worship, Convents, Hostels, Boardings, and  
 other Charitable Institutions in India belonging to the Diocese of Tiruvalla.

(b) Receiving donation, contributions, annuities, compensation or rent or subsidies,  
 assistance etc. due from the Government institutions, persons, or  
 groups, etc using the same for the said aims and objectives.

(c) Raising the funds by way of collection from the public, by cultivating land of the  
 institutions, and other legitimate means of income generating projects.

(d) The supply and maintenance of professors, teachers etc. and of books and other  
 necessary articles incidental to the carrying out of such educational ventures as may from  
 time to time seem good and necessary in the estimation of the Governing Body and in  
 accordance with the Education Rules and University statutes of each state of India.



(e) Framing necessary rules and regulations and to get recognition from authority, if necessary, and framing a scheme for Management for effective achievement of the said aims and objectives.

(f) As the corporate educational agency of the Catholic Diocese of Tiruvalla belongs to the minority community of the Syro-Malankara Christian Catholic Church it shall enjoy all the rights and privileges of the minority community granted by the constitution of India Article 30(i).


